

STATEMENT ON BEAVER MARSH

A little over one year ago - on March 27, 1956 - the citizens of Eugene rejected the bond issue proposal of the Eugene Water & Electric Board for the raising of 8½ million dollars for the construction of the Beaver Marsh project on the Upper McKenzie. Those who took part in the campaign know that the issues were thoroughly discussed. The Eugene Water & Electric Board presented its case through newspaper advertisements, radio, television, signs on buses, direct mailing of illustrated brochures and of course by means of its employee personnel. The Savethe-McKenzie Association had, in fact a small organization, but one that was ably directed and could call on the assistance of key people, including of course mem-The citizens of bers of the Obsidians. Eugene are now faced with another campaign on this issue. What factors are present now, or what changes in the situation have taken place since the March 27, 1956 election? The following, Ithink, are important:

- (1) The local problem of EWEB has been improved substantially by the arrangement made last year whereby EWEB will participate in the Priest Rapids Dam Development in Washington State.
- (2) According to the Bonneville Power Administration's 1956 Advance Program, the power outlook for the northwest has improved substantially since the similar report of 1955. At that time deficiencies (Continued on page 3)

The Climbing Committee reported that the outdoor sessions of Climbing School were successful. Four qualified leaders for the club were graduated. A start of climbing season will be held the latter part of May in conjunction with the University Alpine Club.

Ray Harris reported that three more 541 stretchers had been obtained from the Red Cross. On May 26th there will be a mock rescue in the Oakridge area. The Women's branch will organize a women's pack unit to aid the rescue teams.

A petition was circulated recommending that Mrs. Frances Newsom serve as member of the Eugene Parks & Recreation Commission(Ed.Note: I do not whether petition was circulated at meeting or elsewhere).

Frances Newsom was appointed to the Scientific Committee.

Ray Cavagnaro reported that a charge of \$50 for two weeks and \$30 for one week has been arrived at by the Outing Committee. Packers are being contacted.

BEAVER MARSH(Continued from page 1) in output were forecast for 1960-61. As a result of increased construction activity by both public and private producers, it is now estimated that the shortage will not occur before 1964-65.

- (3) Results of the recreation survey of the U. S. Forest Service have been made public. Under the plans prepared by the Forest Service, the region of the Upper McKenzie, comprising generally a strip of from one to three miles inclusive of the main stem of the Upper McKenzie and the highway, will be set aside for recreation. Such use is of course incompatible with dams, tunnels, diversion works, transmission towers, etc.
- (4) Increased construction costs will result in a less favorable picture for Beaver Marsh itself.

The old arguments still hold: the primary value of the area for recreation; the dollars-and-cents figures on the tourist industry, perhaps the only expanding industry in Oregon today; the coming use of natural gas; the potential use, perhaps within 10 to 20 years, of atomic energy for power generation; and the many unsolved questions at to feasibility of Beaver Marsh based on insufficient hydrologic, geologic and engineering data. To sum it up, I would say that if Beaver Marsh was a poor proposition in 1956, it is an even worse one now. The great resources of the Upper McKenzie may be preserved without any expenditure, but once the area is invaded and the dams are built. it can never be restored. Clear Lake will be a fluctuating reservoir, with resultant damage to its natural beauty and aquatic life. The falls will cease to be natural objects of beauty and will become, instead, controlled parts of the engineering set-up. Let the turners of dials and the watchers of gauges busy themselves in other places. The great waters of the McKenzie deserve a higher destiny.

SUMMER CAMP SIDELIGHT....by Ray Sims Hinton Creek "Camp Bovard" in 1929, is only $\frac{1}{2}$ mile from Husband Lake, this year's campsite. In this 2nd club outing 11 made an overnight trip to Green Lakes "for the first time" between Middle & South Sisters, camping near the big Green Lake. Broken Top was climbed; in returning, a complete circle was made of the South. I made this trip again in 1953, and it was hard to believe it to be the same place with so many moraines pushed up and snow fields turned on end and one lake even divided into four small lakes.

ACTION ON WALDO LAKE

The Obsidian Directors at their last meeting, on the recommendation of the Conservation Committee, Doris Sims, Chairman, meeting jointly with the Science Committee, Frank Sipe, Chairman, voted: 1. On Waldo Lake: a. To ask the Forest Service to plug the leak through the tunnel. reclassify the Waldo Lake area as a Wild Area with provisions for (1) A corridor along the present road for access by car and boat trailer; (2) Extension of the southwest boundary, a mile or so to highway 58 to protect the view from the highway and in lieu of the former buffer strip. (3) To ask our Congressmen to get the Waldo Lake project of the Army Engineers "de-authorized" in line with the

discussion of both Forest Service and Engineers at the recent public meeting sponsored by the Lane County Parks and Recreation Commission. 2. On Billboards on the new federal highways: to inform Senators and other appropriate members of Congress to provide as much protection as is possible to get at this time along the new highways.

In response to a request the Forest Service for the Friends of the Three Sisters to suggest appropriate Natural Areas, it was agreed to offer cooperation of the Friends and particular. ly that of its Science Committee in the study of such areas in the fifty-three thousand acres excluded from the Wilderness Area. But it will again be emphasized to the U.S.F.S. that the best advice of this committee, and of many other leading scientists in the U.S. is that (Continued on page 5)

FRIENDS (Continued from page 4) science will be best served by leaving the 53,000 acres untouched and continuous with the Three Sisters Wilderness Area. And it was stated that the Friends are interested not only in this excluded area but in the whole Three Sisters Region of the Oregon Cascades. The Forest Service was urged: (1) to improve access by better maintenance of trails and trail bridges and by improvement of camps at the edge of the area; (2) To reclassify Waldo Lake Limited Area as a Wild Area in accordance with its plans of 1950-51, with a corridor on the line of the present road providing access to the Lake by car and boat-trailer. Congressmen were asked to obtain the "de-authorization" of the Waldo Lake project of the Army Engineers.

Karl Onthank and Frances Newsom were re-elected President and Secretary respectively, and Al Kirnak, O. K. DeWitt, Dr. James Kezer and Lawrence Merriam, Jr., Vice-presidents and Al Kaufman, Treasurer.

Trips planned into the area this summer were reported: (1) The annual Three Sisters Wilderness Expedition sponsored by the Friends of the Three Sisters with the cooperation of the Obsidians, July 4,5,6, and 7 - Dale Carlson, Chmn. of the Committee, Margaret Markley taking reservations; (2) The Sierra Club Knapsack Trip in this Area August 11 to 17; (3) The Obsidian's Annual Outing at Husband Lake, August 4 to 17; (4) The Obsidians! August 31 to Sept. 2 Waldo Lake Trip, and numerous Obsidian trips during summer and fall into the general area including the May 26 Thor's Hammer - Deathball - Harvey Mt. trip led by Margaret Markley and Dave Burwell.

Follow it to the Larch Mountain Road, which is after Corbett and a little before Crown Point. Bear right on the Larch Mountain road quite a ways until you come to Multnomah Basin Road, which is gravel and takes off to the left. A big tree stands in the middle of the approach to this road and there will be a sign on it. Follow the signs to the parking lot and hike to the lodge.

The program calls for supper about 6:30 p.m. Saturday evening, and a general campfire and discussion on the Columbia Gorge will follow. At least one representative from Oregon's Columbia Gorge Commission will be present; but the idea to get together and exchange ideas and have a good time is the main objective; the Trails Club members are wonderful hosts.

On Sunday, after breakfast, there will be a hike to the Gorge area, returning in time for a 1:30 p.m. big dinner. that one may leave for home, so it will not be late.
